Dear CRN6 members,

Hello! We hope you're doing well. So, after polling your plans for next summer's Law & Society Association Meeting, we are excited to announce that CRN6 will be organizing panels for the 2022 Global Meeting of the Law and Society Association, some will be held virtually and others will be held in-person in Lisbon, Portugal from July 13th-16th. It is important to note that as of now, LSA is requiring that each panel be held either entirely in-person or entirely virtually. We are hopeful that LSA may either change its mind about this rigid requirement or allow some informal flexibility but at present, all presenters and panelists must decide whether they will be presenting in-person or virtually. So, paper and panel proposals will need to select either a virtual or in-person delivery modality for all participants in each panel.

As the conference planning process moves forward, we will look for creative ways to try to bridge our CRN6 virtual and in-person sessions. We will see if LSA might permit us to broadcast our live sessions so that virtual attendees may observe and participate, and we'll look for ways to make the virtual sessions more connected to the in-person attendees. However, for now, if you are planning to organize a paper panel or roundtable, all presenters/panelists will need to commit to participating in the same modality -- either in-person or virtual.

The theme of this year's conference is "Rage, Reckoning, & Remedy" which we encourage you to interpret broadly and look to for inspiration for your conference paper or panel proposal.

We encourage full panel session proposals with at least four, but preferably five, papers in each, as well as individual paper submissions that we'll group into panels. Please orient session and paper proposals to the overall conference theme and our CRN's aims and scope (sex, work, law and society). Submissions that use intersectional and transnational frames are particularly welcome. We ask participants to consider forms of resistance, particularly in the current socio-political context, which explore sex workers' and activists' strategies of resistance. Finally, we are especially interested in abstracts related to this list of possible conference themes below:

- An abstract of 100-200 words (850 characters), which summarizes the significance of the book for the socio-legal community. The description must include the name of the publisher and the date of publication. Please also indicate here if you prefer to present in a Salon format;
- Keyword selection(s).

Note that you do not have to be a member of LSA or any of the co-sponsoring organizations to submit a proposal. However, after notification of conference acceptance, registration is required.
